Discussion of goals for the ABM

Three points of strategic plan: raising profile, engaging membership, assessment

Raising the Profile/Engaging Membership:

Maria and Joe's NEH report/Humanities Connections Grant opportunity (Joe, Maria, with others jumping in)

- Mandate to address federal funding for undergraduate research in the humanities came from CURAH ABM discussions dating back to 2013.
- Advocacy committee
- 1 year ago at CUR Dialogues 2015, NEH Digital Humanities (ODH) presentation by Jennifer Serventi, Senior Program Officer from NEH/ODH who met afterwards with Maria and Joe and is an in-house advocate for UR. A follow-up meeting was held in March 2015 at NEH office in Washington, DC. Joe, Maria, Lindsey Currie, Kuna Tavalin, and Beth Ambos met with NEH program officers from a variety of areas; most of the officers hadn't much information about UR except for Jennifer who had done UR.

- Jane Atkins, Director of Research Division if you look within the research division, there are opportunities but they're not specifically framed as such.
- Jennifer Servanti, Digital Humanities, although not specifically referenced, undergraduate research can be funded in a strong proposal.
- Katja Zelljadt, Challenge Grants; Wilsonia Cherry, Education, Adam Wolfson, Assistant Chairman for Programs also participating with various degrees of engagement and informed us that the Challenge grant was being rethought which might offer potential for a new funding project.
- Maria and Beth wrote a Letter of Inquiry for follow-up, with a tentative budget to
  propose a collaborative CUR-NEH sponsored Institute (invitation-only) to precede the
  CUR Dialogues Conference in February of 2016 to explore the value and impact of
  undergraduate research in the humanities in American higher education. To precede
  the Dialogues Conference would take full advantage of the existing hotel arrangements
  and make the location easier for NEH participants. Consultation with CURAH Division
  leadership and CUR Executive Board.

When this proposal did not advance, Maria and Joe worked with Beth to hold a miniversion of the proposed institute during Dialogues 2016 on Friday, February 19 which featured an opening town hall plenary session on Friday, February 19th, "Introduction and Plenary Session: Town Hall Meeting: Promoting Undergraduate Research in the Arts and Humanities," with Dialogue attendees across disciplines; Core questions were distributed and discussed; after the reportage and concluding comments, all notes were collected for analysis; Maria transcribed them and prepared Town Hall Meeting Report (distributed for A&H Councilor review and discussion). This information provided broadly interdisciplinary perspectives on "what is UR in the arts and humanities." This first morning session Plenary Town Hall Meeting framed an Arts and Humanities programming focus for the rest of the day as each concurrent session featured a program officer from either NEH or NEA. Digital Humanities (Jennifer) very open to projects that include UR and she distributed an informational sheet highlighting UR.

• Challenge grants are under a broad revision and both Research and Education presentations acknowledged UR in the humanities.

At the day's closing plenary Eva Caldera, the NEH Assistant Director for Partnership and Strategic Initiatives, announced important program initiatives including new grant opportunities which would address graduate and undergraduate education in the humanities! Funding from rethinking of Challenge grant. This new NEH funding opportunity *Humanities Connections Program* was formally announced on April 29 with a deadline of October 5<sup>th</sup>. <u>http://www.neh.gov/grants/education/humanities-connections</u>

Faculty from at least two departments or schools at a single institution must collaborate to devise new curricular arrangements; looking for humanist/STEM connections, maybe?

- Projects must include provisions for high-impact student engagement activities related to the topics (long verbiage here, but clearly UR is included)
- Three linked courses
- o \$100 K grants

- o deadline October 5, 2016; can commence May 27, 2017
- Program Officer: Julia Nguyen 202-606-8213 (read the guidelines first)
- Important to get the word out about this grant so there is a strong application response.
- So, success and the work left to be done is to get NEH to be more specific about the acceptability of UR in grant proposals in the other divisions
- Foundations (e.g. Mellon) private funding that allows for UR in the budget (Mellon has given grants when PI's or institutions approach them but they don't have a specific program) Maria and Joe
- Also need to address UR and NEA Maria
- National Humanities Alliance; <a href="http://www.nhalliance.org/">http://www.nhalliance.org/</a> are looking at humanities majors in business and medicine

# Plans for next year in terms of the pillars

Joe: commitment to diversity of ethnicity, gender, institution type (community colleges)

- Bill -- mine CUR databases for people at CCs from sponsored institutes, etc., enhanced members, NCUR participants, directors of UR...
- Joe use AAC&U connections
- Sara people from Dialogues

- Alexa financial support for targeted councilor-categories (HBCUs, Tribal Colleges, Hispanic-Serving institutions)
- Bill -- \$2,500/year budget (goes back to CUR at the end of the year if unspent); any donations to CURAH; endowed fund
- Ruben: how to cast a broad net (not just our "neighbors")
- Lynnette: more artists!
- Joe: not too many councilors from the same college/department within the division; not a rule but an informal agreement

Assessment: in relation to the humanities and arts—to devise and implement ways to assess UR in the A&H:

- What are we assessing? And what are the tools CUR Assessment Webinar?
   Best practices and guidelines; maybe a CURQ article out of a data-collection process
- Rubrics: self reporting, student outcomes, workforce issues
- CURAH GoogleDoc; set it up for assessment -- what works, what we do, what is the vocabulary for assessment

Raising profile – budget?

- This year: Funding for undergrads to go to NCUR (4 funded, 3 used it); 8-10 applications
- Going forward: Funding might target faculty-types to attend ABM as councilors?
- Arts Advocacy Day funded out of budget
- Revisit how we disburse funding

Sara: Email from Finance--Sandra Webster on the divisional budget Questions to consider: How does divisional allocation help? Assess impact of divisional spending and how to spend going forward.

Susan Larson (CUR president-elect)

- Priorities from divisions to e-Board and National Office (NO); will help with planning and direction
- (Sara); Ian's survey of disciplinary affinities could the NO do this?
  - Susan Robin may be the right person for this
  - National Office should at least be in the loop
- (Alicia); could there be an event/interest group/workshop on interdisciplinary research?
  - o Conversation opportunities at ABM/Conference
  - CURQ articles (publication opportunities)

Finance questions (yesterday's homework)

- Currently 400-500 goes to Arts Advocacy Day. Four grants to students \$375 for attendance at NCUR or another conference. A little left over for last minute projects, e.g. Dave the Potter in 2014.
- Lynnette: reports figures we're still forfeiting a lot of money (sometimes travel awards aren't claimed).
- [Discussion of how we could more effectively get info out about funds and how we could disburse them more broadly]. Options discussed:
  - Julia; possibly paying travel and/or membership expenses for councilors from underrepresented institutions/groups
  - Maria; community college faculty sponsorship, and Humanities Advocacy Day
  - Michael; an in-process award for projects that are not ready to be presented
  - John; we are not perceived as a funding source, and we might need to advertise; also website redesign and content development that will do a better job of advocacy – contacting PDs to let them know about the opportunity.
  - Sara; registration fee offset for community college reps (\$175)
  - Ian; cocktail party or reception at professional associations a chance to hand out pens!

- Stephen; student-focused funding for travel and research. Also some online tools for winning presentations and posters: How to generate an excellent A&H Posters on the Hill (POH)
- Joe; longer lifespan expenditure divisional blog or website with testimonials Jenny's presentation on "how to do a poster" make it available or create a short video. Lynnette also has one
- Iain; POH very expensive. Could we support teams presenting there?
- Bill; MLA/AHA etc. (this got a bit muddled) distributing materials at these conferences
- Cheryl; sponsoring an undergraduate at regional conferences [or sponsoring a session Alexa]
- Tom: inclines toward the travel sponsorship, but something more substantial to make it worth applying to?
- Ruben: a model for actually spending all our money
- Bernadette: regional model seems viable/honors societies
- Cheryl: regional conferences getting the word out, roundtables
- Greg; UR research project collaborating across campuses on getting the word out about CUR. Social media tie-in
- Lynnette: ideas from finance travel awards, mentor awards, webinars, co-sponsoring REU/summer scholars.

Alexa: proposes to post the list that we have so far and we will rank it.

Committee/Task Force reports:

- Nominations: Alexa defining who we are; call for more diversity and statement for divisional page (Sara will draft a statement and we will discuss tomorrow);
- Assessment: Iain tomorrow's committee meeting will be a general discussion open to all councilors; look to disciplinary associations for best practices
- Program review: Michael they would like to see a CURAH program review, they are also looking for program review opportunities at a department level (collected names of program reviewers); best practices webinar?
- Internationalization: Alicia and Julia a "how to" document on internationalizing UR. A sort
  of "international studies 101." Also an idea for a directory of international UR mentors.
  Funding opportunities from the nations themselves
- NCUR oversight: John focused on internal procedures, NCUR Oversight Committee wants to continue to push Arts and Humanities participation; we need to identify a follow-up representative
- Advocacy: Maria the committee will develop a plan to approach NEA (Lynnette)
- POH: Ruben how should reviewers be recruited (start with councilors or go straight to members). We go straight to the members.
- Student Programs: Stephen and Cheryl subcommittee on recruiting student CUR ambassadors; needed \$40k got \$5K from CUR to pilot the program. There is a good commitment to all forms of research and creative activity. Recruiting for faculty members will begin with good A & H representation on the recruiting committee.

- CUR Fellows: Bernadette, awards will be given at the conference on Sunday at 5:15 and call for next round out this fall
- Innovation: Joe IDEA Grants three-year project to create "model programs." Some confusion about membership on the Task Force, because the incoming president has to vet nominees
- Finance: Lynnette tomorrow the committee would like answer the two questions sent in Susan's e-mail (read at the beginning of this meeting).
